**4. MINUTES:** The minutes of the Parish Council meeting held on 9<sup>th</sup> September were approved.

#### 5. HILLFORTS WARD REPORT:

Cllr Jespersen spoke of the importance in responding to the Governments White Paper Surveyas this means big changes for how housing numbers are determined in the future and could potentially mean that the housing requirements targets could double for Dorset. The Government will decide on land that will be allocated for houses and consultations will only be taken into consideration if an application is made to build houses on 'protected or conservation areas'. Care must be taken when answering the questions as a yes answer with conditions or specifications will only be considered as a yes, and additional comments will not be taken into consideration.

### 6. DEMOCRATIC PERIOD:

Mr Armitage thanked the PC for their work in obtaining new road markings from the Hilltop Roundabout down towards Letton. He also enquired whether there was any update regarding the Blandford + Neighbourhood Plan. Cllr Jespersen and Cllr Slocombe both confirmed that the matter was still in the hands of Dorset Council's legal team.
